#### **Total proposed Budget**

The budget presented appears high, however, the \$13,228.00 is an inflated number based on the annual Activities Budget. The realistic budget for the ASC to consider for the Activities Sub-Committee is \$800.00. Activities has its own bank account (since 2011 or 2012), and that committee is virtually independent of the Area in financial matters. The only funds to flow from Area to Activities, by policy, are \$800.00 per year (if needed). Adjusting for this fact, the overall area proposed budget for 2016 is \$10,595.00. In the calendar year of 2015, income from Group Donations, the Activities Sub-Committee, and DACNA total \$14,092.00. Please Note: All but \$50.00 of the monies from DACNA were passed on to the Florida Region.

Please also note that NO budget has been submitted for Fellowship Development. At this time the Fellowship Development Sub-Committee is dormant.

The proposed budget can be supported.
