Sean W. questioned the Connection between carrying the message and any theoretical financial issues. George Doubts that the dissolution of DACNA would increase involvement in other area Subcommittees; fellowship involvement is a problem in all areas whether a convention Exists or not. The second motion is to put in policy that DACNA must provide a monthly Financial final line item account. The third motion is that no DACNA committee member Should be a vendor or paid performer at the convention due to conflict of interest. Courtney B. cited DACNA policy that no committee member be a main speaker, and it Follows that this be extended to vendors. 3300 was taken off prudent reserve for the Deposit. George D. brought up convention theme and pre-convention t-shirts for Discussion—decisions can be found under new business. George D. is in process of Applying for a table at World for Sunday morning 8-10 am to sell merchandise; he Doesn't think we can promote DACNA pre-registration at World. Courtney B. suggested Flyers with registration info to circumvent the anti-registration policy.

The committees were asked whether they knew their Budgets; those who requested said info were given their respective budgets (Registration—\$5389.34; Hospitality—\$1387.14; Entertainment/Fund—\$3592.11; Programming—\$1436; Arts & Graphics—\$484). Scott R. worried about not having Enough money due to Hospitality's under spending last year, which lowered budget; George D. explained that he returned \$200 worth of stuff from Hospitality. Courtney B. Conjectured that it may not be a problem due to the separation between locations, and Pointed out that all committees are going to have to be frugal this year, but that we will Be supportive of each other should one committee run out of money or supplies. Tina H. Suggested selling food and drinks as a convention in West Palm does, to which George D. Replied that the Ocean Center will have concessions. The current balance is \$12437.22. Lane J. will not be at the next meeting due to a family commitment.

Sean W. motioned to table theme vote to next month; Scott R. seconded; motion passed.
- Four general ideas for a preconvention t-shirt were brought to the floor: hope dealer; keep it simple stick figure; dream dealer with Disney-style D and NA symbol in the a; true to the blue with o as NA symbol.

The group voted on 'true to the blue' with o as NA symbol as front design. Back design to resemble rock-style tour date listing of previous themes with their corresponding dates in reverse chronological order (DACNA 20 centered at top, May 10-12, 2019 underneath, then two columns of 9 themes, with the first theme centered at the bottom). The group decided on ash t-shirt with black lettering, and the NA symbol in royal blue.
