**Policy Report:** The vice chair was the only one in attendance at the Policy subcommittee meeting in January. I was contacted regarding motion 16/01/03, which states, "The area shall keep it's accounts on the basis of a fiscal year beginning on January 1 and ending on December 31 of that year." The intent of that motion was to align policy with our current business practices. I received feedback that this caused some confusion because we recently passed motion 15/02/06, which states, "To move the Daytona fiscal year to June 1 to May 31." Both motions are in order because they each deal with a separate area of business. The motion to move the fiscal year from January 1 to December 31 deals with budgets at the ASC. The motion that speaks to moving from June 1 to May 31 is for tax reporting purposes. To eliminate confusion, as the maker of the motion, I shall withdraw the motion and resubmit one today that says, "The area shall keep it's budgets on a year from January 1 to December 31 reporting income and expenditures to the ASC body." The motion regarding the fiscal year moving from June 1 to May 31 passed and is in a new subsection titled Tax Reporting under Financial Reporting in the new policy packets which are being distributed today. As you will see when you look at the policy packets they have not been approved by the area since 2013, they are a compilation of motions which have all passed by the area, but the packets as a whole have not been approved recently. Policy currently has all positions open and you only need one day clean and the willingness to be on the committee so I encourage everyone to attend and participate. It is a wonderful way to learn about the traditions, concepts, and how our area conducts business. Policy meets the 2<sup>nd</sup> Sunday of every month at 6:00 pm at 730 Beville Rd.
